<u>ARCHITECTURAL APPROVAL</u> - Homeowners are reminded that any changes or additions to exterior of homes or to properties, including painting, landscaping & replacement must be approved by submitting completed Architectural Approval Form. Work should not begin on any project until approval is received. You can get forms online thru our website or call 540 658-0081.

YARD MAINTENANCE - Please keep our neighborhood beautiful by mowing your lawn and curbside. Trim shrubs & trees planted to close to your house as they can trap moisture & damage siding. Trees on curbside and by sidewalk are responsibility of the homeowner to trim and maintain at all times.

<u>LIGHTING</u> - We are encouraging all neighbors to think about keeping your garage doors closed & using LED lighting. Help us all to keep our neighborhood safe.

PARKING – Be mindful of on-street parking to not interfere with the flow of traffic or block neighbors' driveways.

FREE TREES FOR YOUR YARD – Trees must be planted within 15 feet of the curb. Tree Fredericksburg will plant, mulch, and water your tree for a year. Contact: 540 207-4298; email: treefred@cox.net. To clarify, please remember all homeowners are responsible to maintain the grassy area between the public sidewalk and the public street.

<u>PETS</u> - Please be mindful of your neighbor's yard and sidewalks when you are walking your dogs. Please pick up all waste (This is a Nudge to Pick-Up the Fudge). Fredericksburg has a <u>LEASH LAW</u> that prohibits owners from letting dogs run free at any time, outside of the Dog Park. Dogs must have license, issued annually for \$5.00. They go on sale November 1 at City of Fredericksburg Treasurer's Office at City Hall. We are asking our neighbors to please bring their dogs indoors when they start persistent barking. There is a noise ordinance law in City of Fredericksburg where police can be called if barking exceeds 15 minutes.

HOMEOWNERS & RENTERS - It is the Responsibility of all Homeowners to ensure their Renters Comply to the Rules of GREAT OAKS HOA Covenants.

<u>WILD ANIMALS</u> - We are having a tremendous fox population in our neighborhood. Please do not put food outside as it is attracting too many wild animals.
